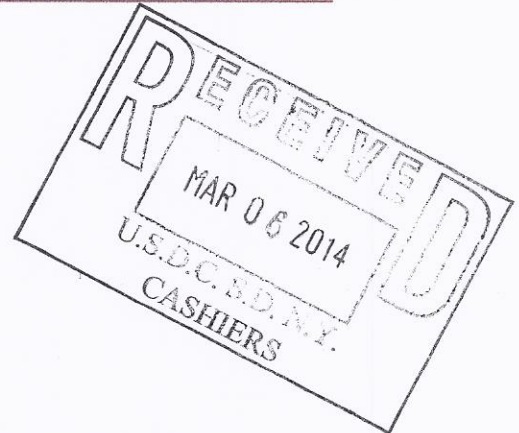

**INTRODUCTION**

1. The action being undertaken emanates from an epidemic of cholera that broke out in Haiti in October 2010. As a result of this deadly outbreak, over 8,000 Haitians lost their
